*Supervisor Bayrd spoke regarding the Budget Amendment passed in 2019. Information on racial disparities in criminal justice, data collection, additional research on racial disparities in criminal justice system – data collection aggregate information on these stats*

*Question regarding periods of time – not concerned about specific dates, 2018 is okay*

*Discussion ensued around looking at the exact same time period*

*I. Ozanne: Can report out, but racial information is not always accurate*

*Clark Bernhardt: Semi-annual reports – 6 months – need to collaborate DPU and Drug Court*

*In review this will be a touchpoint –not a connection of data points to another. There are some duplicate participants*

*Clark Bernhardt will come back to the CJC with a template and suggest a smaller team work on fleshing this out*

2. Safety and Justice Challenge Reflections

*Dane County perspective: done more work with data and racial disparities than others in SJC, datasharing MOU, crime classification*

*N. Reyes stated that everyone facing challenges integrating these huge datasets, but they are at starting point – we are pretty advanced in types of activities and analyses*

*Question: Practices that work with or without data – are we doing those?*

3. DCSO and National Association of Counties

*Chief Deputy Jeff Hook presented.*

*Discussion ensued the Cap Times article:*

*Dane County as example about mental health, BadgerCare eligibility for jail reentry; at National Association of Counties conference, National Association of Sheriffs conference*

#### 4. Familiar Faces project - initial work

*Discussion Ensued:*

*Data Drive Justice – Best Practices Implementation Team*

*CJC, Human Services, Sheriff's Office, Madison Police Dept, and Dept. of Corrections*

*Booking alerts eventually*

*Data integration; lot of work to get to where we are*

*10+ bookings in 3.5 years. Sometimes 4 bookings in one year, but we have a longer time span*

*Drop offs and then reappear. Longer time is better*

*Definition of SMI/MI, or substance abuse—opiate use*

*Can we breakdown the diagnosis section?*

*Familiar faces in different agencies. Is this an analysis you would like to see regularly; is this helpful; does it drive policy change?*

*Question: What is full sample size of people booked? It would be helpful to know how many people are booked total. Even if just 1% can be very large economic hit across agencies.*

*What percentage of total bookings they account for? Booking alert can come out of this project. The people who come in are the ones who cycle, get pushed into system and not stabilized. Then there are competency issues – then they are stuck in the system, only show up 3-4 times, but that is because they are sitting for a really long time; if they had been stabilized, we would not see them; if we do not follow through, they will just come back in. Need to think about details of data to identify that cohort. These people are responsible for over 3000 bookings – would like to envision people to identify these are the familiar faces, and need attorneys with special skills because they need to have their rights protected, can not have attorneys randomly assigned to these people on either defense or prosecutor side.*
