1. Quarter 4 PSA (Pretrial) Data

I. Anadon presented the quarterly descriptive data on PSA.

May 26th to December 31st, 2018: 20% had a hold. Demographics race, ethnicity, and age. 25-34 age is the largest group.

Charge information: the number is inflated because some inflators count as charges and should not. Charges cap at 30. 73% are not violent charges. 18% on parole hold. Recommendations: court commissioner recommendation exceed 12% to PSA, (see footnote) some cases seem to be unresolved.

Judge asked if the highest category for cash bond is capped at 2500 or higher. The question about breaking down the amounts of the cash bail. Luminosity created this PSA

C. Dorl asked about Page 4 – vs Page 6 the difference is no release information.

Judge asked about the break down of LatinX as a percentage (6%) of the white population.
