Policy Analysis Statement:

Brief Description of Proposal -

The HIV Consolidated Contract Grant aims to reduce HIV transmission rates through a variety of activities. Public Health-Madison and Dane County (PHMDC) received an additional \$137,000 in funding to expand this work and provide new/additional services through the creation and hiring of a bilingual/bicultural Disease Intervention Specialist.

Current Policy or Practice -

Creation of project positions requires approval of the County Board.

Impact of Adopting Proposal -

The position authority would increase by 1.0 FTE and the salary and benefits of this newly created position would be come from increased revenue from the WI Department of Health Services HIV grant as part of the Consolidated Contract
