- Youth Governance Program-No report, Edgar shared that Jess Calkins is working with the County Board office on finalizing assignment of mentors for all new members.
- Director report – Edgar shared that Jess Calkins has accepted the part time Community Food Systems Coordinator position and will continue with the part time youth development coordinator position as well. A new partnership is in the works with Dane County Farm Bureau to offer the Ag in the Classroom program starting this fall.
