Greg Payne, Senior Project Development Engineer and Jeremy Rach, Design Engineer for the Wisconsin Department of Transportation, provided a presentation and update on the WIS 19 resurfacing and reconstruction project between WIS 78 and US 12 that includes several park properties: Halfway Prairie School, Halfway Prairie Wildlife Area and Indian Lake County Park. Payne explained that there are a number of safety issues that are driving this project. The primary issues include very narrow shoulders and sharp curves. The shoulders will be widened to 6' from the park entrance east to US 12. The goal is to have all the project planning work completed by this fall with a tentative construction date of 2023. Payne stated one of the safety measures they're hoping to provide as part of this project is a highway underpass for pedestrian access between Indian Lake and Halfway Prairie. The underpass will also serve as the trail route for the Ice Age Scenic Trail. Payne mentioned that they have been working internally with the bike/pedestrian planners and have decided on an 8' corrugated culvert vs the 7.5' culvert initially proposed. Payne provide the commission with plans that showed a rendering of the proposed design and conceptual site plan.

Discussion: BOGUE stated that she thought it looked too dark to be inviting to users. THORESEN stated that RIPP, BROUWER and he had visited the Treinen Farms Underpass on Highway 60. RIPP and THORESEN both thought the Treinen Farm underpass had enough light and was plenty wide. BROUWER stated that she thought it didn't look or feel like a public use facility. She thought the culvert design looked and felt like a cattle pass, still preferring a concrete box culvert design. RIPP stated that concrete stays damp and moist all the time. THORESEN stated that he didn't like concrete because it stays damp and algae builds up to make slippery conditions. Users need to be careful when walking or riding through them. EICHER asked if the underpass could be a project for the Dane Arts Commission to involve painting it or using art to make the structure more inviting. BROUWER stated that these are two premier park properties. Indian Lake is one of the most heavily use county parks especially for hiking. The Ice Age National Scenic Trail will also pass through the culvert. THORESEN stated that he would like to see the wing walls or headwall provide a better entrance way for the culvert underpass. BROUWER stated that at least the entrance should be more welcoming. RIPP stated that Dane County Parks will need to create the trail system that will lead the public to the underpass. RIPP stated that there are still a few issues to work out before action can be taken on the De Minimis letter. The commission asked Marsh to work with WisDOT officials to see if there were opportunities to adjust the letter, considering the commission's suggestions for the underpass.

## Web Based Reservation/Permitting Systems and Fee Collection Kiosks

*Marsh provided the status on the County Purchasing Department's RFP for a new parks web-based reservation program. The deadline for proposals is July 24th. The goal is to have a new system in place for 2020. Marsh stated that the Commission has already appointed BOGUE and BROUWER to a subcommittee to help with the review of the new reservation program. Marsh stated he had a couple of policy changes related to the new program including making all campsites reservable; currently 23 out of the 175 campsites are non-reservable. Marsh stated campers want to know site availability and a guarantee they can reserve it vs driving around from one campground to another on a chance for a site.*

*Marsh also stated that the division wants to offer a more customer-friendly way to purchase permits in the field by using credit card self-registration kiosks. Marsh stated that over time, the goal would be to do away with the cash collection tubes. These tubes are constantly being broken into and vandalized, with permits and money being stolen. With the credit card machines, there is no stealing of cash or data, and no staff time taken to maintain the collection tubes. Most public agencies are already using this service vs cash collection tubes. As a trial, two credit card kiosks will be purchased and installed at Capital Springs this fall. If these work successfully, the program will be expanded to include other parks and recreation facilities.*
