Provide a detailed description of the goods/services intended to be purchased:

Barriers to Employment Project (BEP) is a new educational initiative created by Legal Action of Wisconsin, Inc. (LAW) and Urban League of Greater Madison (ULGM) devoted toward removing legal barriers to employment for Dane County's residents. LAW project staff will educate residents on how to remove legal barriers to employment. The goal is to have LAW/ULGM project staff provide the following services to Dane County residents:

• Education, and assistance for County residents with the restoration of driver's licenses;

• Education and assistance for County residents with clearing and cleaning criminal background and arrest records (i.e. Wisconsin Criminal Information Bureau (CIB) reports), including expungement and expunction of eligible criminal records/arrests/activity.

The Provider will offer the above educational services through expungement and restoration clinics coordinated by ULGM/LAW staff working with municipal, community, and private sector partners

• The Provider will coordinate with ULGM and community partners to hold at least four

(4) expungement and/or restoration clinics;

• The Provider will request, review and discuss driving records and/or criminal background and arrest reports (i.e. CIB reports) with an average of 80 Dane County residents facing legal barriers to employment per clinic, for a total of at least 320 Dane County residents in 2019 in order to provide these residents with the information needed to address their specific barriers.
