WITNESSETH:

WHEREAS, COUNTY, whose address is c/o Todd Draper, 1919 Alliant Energy Center Way, Madison, WI 53713, desires to have CONTRACTOR provide Job Center Restroom Expansion REBID, Dane County Job Center ("the Project"); and

WHEREAS, CONTRACTOR, whose address is 3624 Pioneer Rd., Verona, WI 53593 is able and willing to construct the Project, in accordance with the Construction Documents;

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is acknowledged by each party for itself, COUNTY and CONTRACTOR do agree as follows:

- 1. (hereinafter referred to as "the Architect / Engineer"), and as enumerated in the Project Manual Table of Contents, all of which are made a part hereof and collectively evidence and constitute the Contract.
- 2. COUNTY agrees to pay the CONTRACTOR in current funds for the performance of the Contract subject to additions and deductions, as provided in the General Conditions of Contract, and to make payments on account thereof as provided in Article entitled, "Payments to Contractor" of the General Conditions of Contract.
- 3. During the term of this Contract, CONTRACTOR agrees to take affirmative action to ensure equal employment opportunities.
