In addition, The Office of Economic and Workforce Development reports that there were no evictions in 2018 at any of the sites funded by Dane County's Affordable Housing Development Fund that would have had tenants in the same year:

Two items of note: 1. Gorman & Co. did not report any numbers to OEWD regarding their Union Corners property. Eviction totals, if any, are unknown. 2. Porchlight reported 2 evictions at their AHDF property, 1221 Sunfield, Sun Prairie. These numbers are reflected in the information regarding Porchlight above.

The OEWD also reports that two HOME-funded projects leased up at the end of 2018 and early 2019 will be reflected in 2019's report. OEWD expects the number of projects reporting under AHDF to increase next year as well, as more projects complete lease-up in 2019.
