D. Presentations

1. Presentation and tour of Festival Foods Nutrition Site. Sonya Lindquist, NewBridge Director of Senior Services.

Lindquist explained effective January 1, 2019 four Madison Senior Coalitions merged to become NewBridge. She stated attendance at Madison area senior centers for meals was decreasing. NewBridge understood that seniors preferred restaurant type settings for nutrition sites, so Festival Foods was chosen as a meal site for seniors to enjoy a buffet style soup/salad bar meal and grocery shop. Approximately 40 seniors come to this nutrition site regularly. This grocery store serves a diverse population; hence, this meal site is reaching a diversified group of seniors. Schnell, store manager, explained the logistics of serving seniors the soup/salad bar.

S. Lindquist explained how the County has an arrangement with NewBridge/Festival Foods to provide meals to seniors at a suggested donation of \$5.00 per meal. No one is denied a meal for inability to pay. Festival Foods provides water, coffee and milk at no charge. Dane County provides transportation to the meal site. Additional restaurant style meal sites in the Madison area are being discussed.

E. Reports to Committee

1. The River Food Pantry

J. Betzig reported the River Food Pantry is providing extra staff on Wednesdays to specifically assist seniors and veterans. Transit Solution through the County elderly transportation program and DryHootch through the County veteran's transportation program will be transporting senior and veterans to the food pantry.

RSVP drivers will begin delivering food pantry supplies from the River Food Pantry directly to the homes of some low income seniors. The volunteer drivers will receive mileage reimbursement.

2. Recreational Activities

J. Betzig explained the new Recreational Activities program. The County is offering scheduled activities with transportation. Three busses are designated to serve Madison East and Monona, Madison West and Middleton and Madison South and Fitchburg. The activity busses will operate through the existing County elderly transportation program.
