



LOCATION MAP

Commencing at the East 1/4 corner of Section 4; thence S88°02'33"W, 1322.74 feet to the Northeast corner of the NW 1/4 of the SE 1/4 and the point of beginning; thence S02°44'30"E along the East line of said 1/4 - 1/4, 750.51 feet; thence S89°39'49"W, 914.39 feet; thence S02°53'11"E, 66.06 feet; thence N89°39'49"E, 914.08 feet to the East line of the NW 1/4 of the SE 1/4; thence S02°44'30"E along said line and the East line of the SW 1/4 of the SE 1/4, 1770.23 feet to the Southeast corner of said 1/4 - 1/4; thence S88°07'46"W along the South line of said 1/4 - 1/4, 998.48 feet; thence N02°53'11"W, 208.56 feet; thence S87°09'12"W, 208.51 feet to the East line of State Highway 73; thence N02°53'11"W along said line, 405.62 feet to the Northwest corner of Lot 4 of Certified Survey Map number 14796; thence N88°14'23"E along said lot, 215.90 feet; thence N44°07'12"E along the West line of Lot 3 of said survey, 60.00 feet; thence N15°37'08"E along the West line of lot 3, 121.33 feet; thence N02°53'11"W, 1454.07 feet to the Northwest corner of Lot 2 of Certified Survey Map number 14796; thence S88°02'33"W, 299.75 feet to the East line of State Highway 73; thence N05°05'32"W along said line, 351.95 feet; thence Northwestly along the arc of a 2,924.79 foot radius curve to the left, 12.32 feet to its intersection with the North line of the NW 1/4 of the SE 1/4; thence N88°02'33"E along said line, 1228.85 feet to the point of beginning.
