### 3. Discussion re: impact the VOCA funding decision will have on victim services throughout the county - Amy Brown

*Brown and Foley discussed services/programs in the DA's Office supported by VOCA grant funds. The VOCA grant is \$80,000 short to maintain status quo. They have appealed as well as reached out to the County Board for more funding; but are also reviewing services not required under statute to determine where cuts can be made and exploring redistribution of victim services. VOCA gaps were discussed, how to scale services down to what is sustainable and work more collaboratively. Crowley will work on a mapping exercise for referrals. There was disappointment expressed in the VOCA process/instructions this year.*

### 4. Legislative Update/Announcements:

- *McCarville explained county budget process. The County Executive will release his budget on October 1. Budget amendments are then proposed through Supervisors/Committees, then they go through Personnel & Finance, then to the County Board for adoption. She encouraged members to contact the appropriate Supervisor to request support for budget funding.*
- *Barry reported that the new policy person at End Domestic Abuse WI started yesterday.*
- *Ginsburg reported that there will be a position posting for a multidisciplinary team coordinator at Safe Harbor soon.*
- *Kretschmer reported that there are three open positions at the Forensic Nurse Examiner program which sometimes causes closures/delays. Her number is 608-417-5863.*
- *Poe-Gavlinski (UW Law School) has six students willing to do restraining order related legal work pro bono. Contact her at 608-890-1596 or ryan.poeavlinski@wisc.edu*
- *Kato expressed interest in working on a media breakfast.*
- *Barry reported that the court watch program starts again in October.*
- *Miyasaki suggested a subcommittee on strategic partnerships.*
- *Statam gave an overview of Anesis.*

## 5. CCR Updates:

- *Child Abuse & Neglect:* Kato reported that the new structure is going well. Subcommittees are developing priorities and the CYF Consortium will be collecting them. The Trauma Informed Summit Advisory Council is working on the Trauma Summit on November 15 at American Family.
- *Intellectual Disabilities:* Freeman reported that they brainstormed topics for presentation and focus.
- *Domestic Violence:*
- *Elder Abuse:* Scarr noted participation in large group has declined, though subcommittees are robust.
- *Sexual Assault:* Sathasivam said that they are eliminating subcommittees except CSEC in order to improve participation. There is interest in collaborating with other CCR's. The next meeting is October 25 at MPD South Precinct from 10-12. LTE Kati Hanson is leaving. Myasaki reported that the CSEC monthly outreach meetings are held at St Johns on the 3rd Wednesday. They are discussing expanding the mission to 21 year olds. Planning a summit for October 2020.
