PARK & TRAIL FLOOD REPAIR GRANT AWARDS

Rigelman stated that she had received 11 grant applications totaling more than \$6,000,000 in total costs. The County has \$1,000,000 in county assistance for flood repairs associated with public recreational areas around the county. Rigelman stated that the grant applications were evaluated by staff to determine the best use of the available county grant dollars. The goal, when possible, was to provide up to half the funding required to repair estimated damages for the recreational facilities. Rigelman reviewed the grant requests and staff recommendations.

Recommended grant amounts included:

- •\$500,000 to City of Middleton for Pheasant Branch Creek Corridor Repairs
- •\$173,536 to Village of Oregon for the Rotary Bike Trail Relocation
- •\$82,738 to Wolf Run Association for Wolf Run Trail Repairs
- •\$29,885 to Town of Dunn for Dunn Heritage Park Restoration
- •\$105,000 to Town of Middleton for Pope Farm Conservancy Restoration
- •\$108,841 to Village of Black Earth for Community Park Restoration
