#### Brief Description of Proposal -

The Dane County Sheriff's office has been operating a precinct station at the Town of Pleasant Springs town hall since July of 1982; the current lease with the Town of Pleasant Springs expires, June 30, 2020. The Town of Pleasant Springs has agreed to extend the Southe ast Precinct lease an additional year to June 30, 2021.

# Current Policy or Practice -

The terms and conditions of the current Southeast Precinct lease, including rent of \$4,875 per quarter, shall remain the same.

# Impact of Adopting Proposal -

The Southeast Precinct has outgrown the space at the Pleasant Springs town hall and plans to relocate to a new space in 2021. The lease extension for an additional year is required to allow additional time to accommodate the County's move to the new location.
