AUTHORIZATION OF SHARED OFFICE SPACE AGREEMENT FOR THE DANE COUNTY- EXTENSION FINANCIAL EDUCATION CENTER AT THE VILLAGE ON PARK

8 The Dane County - Extension Financial Education Center (FEC) was established in 9 2005 to increase the financial literacy skills of residents in Dane County thereby 10 empowering them to achieve financial security. The FEC has become a "one-stop-shop" 11 community resource offering integrated financial education classes, individual coaching, 12 and referrals to other community programs and services. In order to reduce overhead 13 and maintain its presence at the Village on Park, FEC began subleasing space in 2015 14 from the Wisconsin Women's Business Initiative Corporation (WWBIC), working 15 collaboratively to sponsor joint events and programming.

The agreement with WWBIC for shared office space expired last year but it has allowed FEC to continue operating in its current space. This agreement covers this current year through October 31, 2019 at a monthly rate of \$237.00 per month and includes three options to renew for a period of one year each which would extend the agreement to October 31, 2022 at a an increased rate of 3% per year. The agreement includes workstations for the FEC's use and access to WWBIC's common areas, as well as use of selected office equipment including the copy machine and all utilities.

Funding to support the FEC comes from revenue generated from key programs and
periodic grants. There are adequate committee grants and projected revenue to
support the shared space payments.

the Dane County Executive hereby authorize the Agreement for Shared Office Space
beginning November 1, 2018 through October 31, 2019 at \$237.00 per month or
\$2,844.00 annually and an option to renew for the period beginning November 1, 2019
through October 31, 2020 at \$244.00 per month or \$2,928.00 annually per the terms and
conditions outlined above with the WWBIC; and

Agreement for Shared Office Space November 1, 2018 – October 31, 2019

The Wisconsin Women's Business Initiative Corporation (WWBIC) will provide office space for the UW-Extension Financial Education Center (FEC) at its 2300 S. Park Street, Madison location. The following represents the agreement between WWBIC and FEC for the use of the office space for the period November 1, 2018 to October 31, 2019.

- 1. WWBIC provides two workstations for FEC's use in Suite 101. The shared areas include storage, in-suite meeting space and access to WWBIC's common areas, kitchen area and copy machine. FEC is responsible for keeping their work areas clean and in good condition.
- 2. WWBIC allows FEC to maintain its own phones and data lines within the space. All maintenance and repairs will be FEC's responsibility.
- 3. FEC has access to WWBIC's office equipment for occasional use. If significant usage is required, a separate reimbursement structure may be negotiated.
- 4. FEC will pay WWBIC rent in advance on the first day of the month. The rent is payable to WWBIC at 1533 N. RiverCenter Drive, Milwaukee, WI 53212, Attn: Accounting. The rent is inclusive of all utilities and is per the schedule below:

Nov 1, 2018 - Oct 31, 2019 \$237.00 per month

- 5. This space agreement is based upon receipt of landlord approval which was provided to WWBIC on May 1, 2015.
- 6. FEC agrees to the general tenant guidelines for the Village on Park property as determined by the landlord.
- 7. FEC will maintain commercial general liability in amount not less than \$1,000,000 and have WWBIC listed as an additional insured on the policy/certificate.
- 8. FEC has paid WWBIC an upfront refundable deposit of \$250.00 to cover damages beyond normal wear and tear. This will be returned after the agreement's termination if the space and furniture are returned in the same condition (except for normal wear and tear).

9. This agreement can be extended beyond October 31, 2018 for three additional one year terms after review by both WWBIC and FEC. FEC shall give WWBIC 60 days notice of intent to extend the agreement for another term. If extended, the payment schedule shall be as follows:

| Nov. 1, 2019 – October 31, 2020 | \$244.00 per month |

| Nov. 1, 2020 – October 31, 2021 | \$251.00 per month |
| Nov. 1, 2021 – October 31, 2022 | \$258.00 per month |

10. Either party can terminate this agreement with 90 days written notice.
