Brief Description of Proposal -

The Village of Rockdale has requested the Dane County Sheriff's Office provide additional police service within the boundarie s of Village of Rockdale, at a level above and beyond the basic level of police service currently provided. The Village of Rockdale has agreed to compensate Dane County for the cost of assigning certified sworn law enforcement officers, including necessary equipment and vehicle, to perform law enforcement service at approximately 4 hours per month. The potential 2020 revenue is estimated at \$3,733.

Current Policy or Practice -

Contracts must be approved by the County Board and executed by the County Executive.

Impact of Adopting Proposal -

Providing law enforcement service to a community is an essential service that is costly, especially for small municipal governments. Purchasing policing service is less costly when compared to the cost of operating a municipal police department or establishing a new police department. The Dane County Sheriff's Office can provide a high level of cost effective service and policing efficiency to the community.
