C. Action Items

1. 2019 Budget Update and Remaining Funds

i. \$250 has been spent for tree diversity ads on FaceBook. \$155.45 spent for reimbursing Extension for Arbor Day expenses (from marketing/tech fund). FOF expenses still discussing, branding iron is \$300 plus \$75 from marketing/tech fund.

 - i. Currently, 127 people reached by tree diversity ad with no boost. To reach more, we can have it put in news feeds with a boost. Discussion on audience to get most response. Research indicated females, 25-65, and new homeowners as best audience. \$250 to be spent on boosting to this audience as per previous motions.
