*NewBridge Madison Senior Services Director Sonya Lindquist distributed the 2019 Cultural Diversity Program Report and stated the organization fell short of contract goals for individuals served largely due to turnover in the coordinator positions for both the African-American and Latinx programs. Lindquist, who assumed oversight of the program upon the merger of the four city aging coalitions on 1 January 2019, stated several initiatives are being considered to improve the numbers of seniors served.*

*Velasquez stated 2020 is the third year of AAA's five-year contract with NewBridge Madison (and the former North/Eastside Senior Coalition), and that if service numbers don't improve dramatically, AAA likely will seek Requests for Proposals to provide cultural diversity programming prior to the expiration of the five-year contract.*
