AUTHORIZING MODIFICATION TO LAW ENFORCEMENT SERVICE CONTRACTS WITH THE VILLAGES OF WINDSOR AND MAZOMANIE

## Policy Analysis Statement:

#### Brief Description of Proposal -

The Dane County Sheriff's Office contracts with the Villages of Windsor and Mazomanie to provide law enforcement service at a level above the basic level of law enforcement service otherwise provided to the Villages; both Villages request modifications to their existing law enforcement service contracts. The Village of Windsor requests an additional certified sworn law enforcement officer and an additional vehicle. The Village of Mazomanie requests decreasing one certified sworn law enforcement officer.

### Current Policy or Practice -

Contracts must be approved by the County Board and executed by the County Executive.

### Impact of Adopting Proposal -

Providing law enforcement service to a community is an essential service that is costly. Purchasing law enforcement service, especially for small communities, is less costly than operating a municipal police department or establishing a new police department. The Dane County Sheriff's Office provides a high level of cost effective law enforcement service efficiency and effectively to communities that do not operate a municipal police department.
