## 1. Discussion on the needs and issues of Latinx youth and advocacy role of the Youth Commission

*This meeting was a follow-up discussion to the information shared by Centro youth at the September listening session. Menéndez Coller shared that Centro offers youth programs on-site (ReGeneracion) and at schools (Escalera and Juventud). The school-based programs provide support, safe space, advocacy for student and parents, academic tutoring, and career exploration delivered by one full-time coordinator and volunteers. ReGeneracion is a youth led action and advocacy program that provides a significant support. The Center also responds to individual needs of youth and families who seek support from the Center. Menéndez Coller and Cruz stated that in all program areas, the needs of youth exceeds the Center's capacity, particularly in areas of behavioral health where barriers to service include insurance and the lack of bi-lingual, bi-cultural options. Centro is trying to add a social worker to their staff and is in discussion with UW on being a behavioral health residency site. They have also been working with UW Center for Education Research on training youth to be evaluators of programs. Centro staff are regularly engaged in community education and advocacy to address issues raised by students related to oppression. When asked what the Commission could do to advocate for Centro, Menéndez Coller identified advocacy for resources to build capacity was the number one priority with evaluation support being a distant second.*
