Provide a detailed description of the goods/services intended to be purchased:

Escalera provides services for Latino youth in grades 6-12 to promote economic mobility by increasing educational attainment, career planning, and access to information about advanced careers. PROVIDER will target youth at risk of not graduating from high school who are Latinx, low-income, grades 6-12, English language learners, and first generation college-bound. PROVIDER shall offer 2 - 4 weekly after-school tutorial and career exploration services at Madison schools including Cherokee, Sennett, Sherman, Wright and Toki Middle Schools and at West and Memorial high schools; group activities/workshops; parent meeting as needed; translation services and/or student and parent support at teacher conferences.Curriculum and program activities focused on leadership/technology training, college awareness, workforce readiness and personal (cultural identity) development are aligned with the curriculum guidelines and logic model that are outlined in the National Council of LaRaza Escalera Replication Guide--a national promising practice model.

A unique or opportune buying condition exists due to the collaborative nature of the project which is funded by Madison School District, the City of Madison, Dane County Human Services, and United Way. The volume, scope and depth of service provided to Latinx youth is maximized through this collaboration with Dane County supporting approximately 30% of the project. Centro Hispano has a partnership MOU in place with MMSD to house Escalera staff at school sites to provide support to students during the school day and after school programming. Staff from Centro are well integrated into the school community. Changing this structure and the funding that supports it would be disruptive to students and difficult, if not impossible, to recreate in a timely manner. Quarterly reporting and annual metrics are coordinated by funders to minimze duplication and maximize resources. This is a strong and committed partnership serving a vulnerable population.
