Captain Bennet R. Lardie CBRN Response Plans Officer US Army (USA)

DOMOPS (Domestic Operations) of the US Military offers several different services and resources to aid municipalities and the public. Many different packages and the services they include were detailed to the committee.

E. Reports to Committee

Madison Fire HazMAT Team Report - Mrowiec

Mrowiec updated committee on chemical-related responses in Dane County. Noted a rise in chemical-related suicides both in county and country-wide.

EPCRA Report - Bursack

Bursack updated committee on progress of EPCRA plan completion. 28 plans are complete; 14 new plans added with 7 near completion; 18 facilities reported amounts of sulfuric acid from batteries incorrectly and no longer require plans. Bursack also noted federal funding has been diminishing over the years for the EPCRA Computer and Hazmat Equipment Grant. Bursack reached out to several rotary clubs and housing association across the county to talk about hazardous materials as part of community outreach.

LEPC Membership Reports - All

Larson reported the VA Hospital has been reviving their decontamination program; they would still rely on UW for mass decon. Ruckriegel reported he was contacted by two separate parties interested in starting hemp extraction businesses in the area which could potentially add large amounts of ethanol and CO2. Bursack reported that Landmark Services will soon be removing large amounts of anhydrous ammonia.
