Brief Description of Proposal -

Request approval to authorize a 5-year towing service contract with Schmidt's Auto Inc., maximum amount paid to vendor not to exceed \$200,000 over 5-years.

Current Policy or Practice -

Contracts for amounts exceeding \$100,000 require County Board approval. Dane County engaged in a competitive bid process for a vendor to provide towing service to the Sheriff's Office, Request for Proposal # 120012, Schmidt's Auto Inc. was the successful vendor in the competitive bid process.

Impact of Adopting Proposal -

Towing service is required to improve safety on the roadway for the public and law enforcement and to minimize the effect inc idents have on the operation of the transportation network. The County is not equipped to provide necessary tow service effectively and efficie ntly.
