Program Report: Betzig summarized 21 transportation programs. She noted rides are not typically provided to Medicaid participants because MTM is available for medical related transportation. The question was asked if the Ferris Huber Center had a bus stop. The bus stop is in front of the Center and bus tickets are provided to the Ferris Center to support employment (rides to and from work). There was discussion regarding the Guaranteed Ride Home Service (emergency ride home for individuals whose primary mode of transportation is not a single occupancy vehicle). It is not a service supported by county funds but is a good resource for the call center to have.

Wegleitner asked if there were changes to revenue from county levy as a result of vehicle registration fees. The amount of County Levy in 2020 transportation budget is roughly the same as in 2019. Wegleitner requested information on where vehicle registration fees go.

A request was made about whether the department collects data on unmet needs. Transportation gaps are identified at the Call Center but the software does not track this information. How are decisions made about what the priorities are for additional funding? Betzig stated funding is used to support successful existing programs first and dispersed based on demographic information. A common transportation request in Dane County communities without taxi/shared ride taxi service is on-demand ride service.

### H. Such Other Business as Allowed by Law

Betzig was asked for an update on the meeting with Fitchburg Senior Center about their transportation needs. In addition to the meeting with Fitchburg, Betzig said a meeting was also held in the last month with all Focal Point Directors. Betzig explained in both meetings that the priorities for the Rural Senior Group Ride (RSG) program is to transport all community elderly and people with disabilities to nutrition sites and grocery shopping. Nutrition is identified as a transportation priority by the funding source for this program. She believes the senior centers request to transport seniors to their center activities is important but conflicts with what the transportation companies are logistically able to do. There was a discussion regarding transportation provider logistics. Some transportation to senior center shift their schedule to make the logistics work and if the vehicle has seats on the bus. The numbers of community riders (all elderly and people with disabilities) requesting transportation to nutrition sites and shopping takes priority.

Lyman shared that City of Fitchburg may be pulling out of Metro agreements.
