Brief Description of Proposal -

The State of Wisconsin, Department of Military Affairs (DMA), Division of Emergency Management (WEM) is providing grant funding, in the amount of \$4,857, for the purchase of emergency police service, mobile field forces equipment, WEM Grant Number 2018 -MFF-01-11899; funding is available 1/1/2020 through 5/31/2020 and shall provide for the purchase of gas masks, CBRN filters, and gas mask carrying pou ches for the Dane County Sheriff's Office Special Events Team (SET). Specialized equipment for SET is required for crowd control events.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

Mobile Field Forces are designed to provide a rapid and organized response to civil disorder, crowd control and emergency situations including natural and man-made disasters and routine local and statewide mutual aid requests from local law enforcement. Specialized equipment is required for the personal safety of mobile field forces SET members to prevent injury or death.
