Funding is confirmed from major sources including Dane County, the City of Madison, Public Health Madison Dane County, United Way of Dane County, and the Madison Metropolitan School District. The Commission agreed with the DCYA Steering Committee recommendation to set small school district fees at \$500 per district and mid-size districts at \$800 (VASD, MCPSD and SPSD) to cover additional time for set up and support.*
