ACCEPTING STATE OF WISCONSIN GRANT FUNDS TO PROVIDE TREATMENT FOR UNMET NEEDS OF THOSE WITH OPIOID USE DISORDER DCDHS - ACS DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

The State of Wisconsin Department of Health Services (DHS) has awarded grant funds to Dane County Department of Human Services (DCDHS) to address unmet needs of those individuals who are attempting to recover from opioid use disorder. Dane County has previously received grant funds from DHS for this purpose, however, the federal source of this grant has recently changed.

Current Policy or Practice -

Budget changes require County Board approval.

Impact of Adopting Proposal -

The funding from this grant is to support activities through the current federal fiscal year, which ends on September 30, 2020. The funding will be used to support the continuation of existing programs that provide treatment to individuals who are dependent on opioids. The services supported by this grant include Medication Assisted Treatment (MAT), which consists of outpatient counseling and medications that are designed to support recovery at Journey Mental Health Center. Grant funds will also be available to provide MAT to those opioid-dependent individuals who are returning to the community from the Dane County Jail.
