SECOND ADDENDUM TO DANE COUNTY CONTRACT

THIS SECOND ADDENDUM, is made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and DaneBuy Local Foundation, Inc. (hereinafter, "Provider").

WITNESSETH:

WHEREAS PROVIDER and COUNTY, by a separate document, Dane County Contract #13980 (hereinafter, the "Master Agreement"), have previously entered into a contractual relationship for the purpose of establishing and administering a targeted small business grant program designed to mitigate the economic impact of the coronavirus (COVID-19) outbreak;

WHEREAS, COUNTY and PROVIDER entered into an Addendum to the Master Agreement, Dane County Contract, #13980A (hereinafter "First Addendum") which supplemented the amount of funding for the grant program by \$550,000 for a total of \$800,000;

WHEREAS, COUNTY AND PROVIDER now wish to further modify the terms of the Master Agreement and the First Addendum to supplement the total amount of funding for the grant program, among other changes ("Second Addendum");

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- 1. The Master Agreement and First Addendum shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This Second Addendum shall control only to the extent of any conflict between the terms of the Master Agreement, First Addendum and this Second Addendum.
- 2. Capitalized terms herein have the same meaning as used in the Master Agreement unless otherwise noted.
- 3. SCHEDULE A is modified as set forth below:
 - Section I.d. is created as follows:

PROVIDER shall also make reasonable efforts to solicit applications from locally owned restaurants, small retailers, hair salons, fitness centers and other local businesses. As part of its outreach, PROVIDER shall ensure

that such businesses in rural communities are also encouraged to apply for grants under the Program.

- 4. SCHEDULE B is modified as set forth below:
 - Section I.a. is deleted in its entirety and replaced with the following:

PROVIDER shall be permitted to retain up to \$180,000 of the Grant Fund in order to cover expenses related to the administration of the Program.

• Section II.a. is deleted in its entirety and replaced with the following:

In addition to the \$800,000 that COUNTY made previously available in the Master Agreement and the First Addendum, COUNTY shall make \$10,000,000 available to PROVIDER, for a total of \$10,800,000 in order to fund the PROGRAM.

• Section II.b.is created as follows:

On a bi-weekly basis, PROVIDER agrees to invoice COUNTY with a list of grant recipients and their respective grant awards. COUNTY shall remit payment within ten (10) days from the receipt of invoice.

- 5. SCHEDULE C is modified as set forth below:
 - Section III is created as follows:

Cooperation. PROVIDER understands and agrees that the funding provided under this Agreement is made available under section 601(a) of the Social Security Act, as added by section 5001 of the Coronavirus Aid, Relief and Economic Security Act, and can only be used to respond to the COVID-19 public health emergency ("Emergency"). PROVIDER agrees to cooperate with COUNTY to the fullest extent possible in order to demonstrate that the Services provided under this Agreement were performed as a result of the Emergency. Such cooperation includes, but is not limited, to furnishing records, providing information when necessary, and making PROVIDER's officers and employees reasonably available to answer any inquiries.
