## Policy Analysis Statement:

## Brief Description of Proposal -

The County's COVID-19 response effort in this area has focused on achieving social distancing in Dane County's shelter system to reduce exposure to illness among shelter guests, increasing access to hygiene for individuals who are sleeping outside, providing safe space for individuals who are symptomatic to isolate outside of congregate settings, and more.

#### Current Policy or Practice -

Budget changes require County Board approval.

#### <u> Impact of Adopting Proposal -</u>

To accomplish these goals, Dane County Department of Human Services (DCDHS) Housing Access and Affordability (HAA) has invested in a number of services, including partnerships with local hotels to provide sheltering for families and individuals experiencing homelessness at higher risk for contracting COVID-19 per CDC guidelines, support for temporary emergency overnight shelter for adult men at the Warner Park Community Center, security services, shelter custodial services, food for shelter/hotel guests, personal protective equipment (PPE) for agency partners and hotel/shelter guests, staff to help sustain shelter operations, and on-site supportive services for hotel guests to help them move from sheltering in hotels into permanent housing.
