Dane County Department of Human Services (DCDHS) - Prevention & Early Intervention (PEI) Division provides localized services in communities
identified as needing those services the most through the Joining Forces for Families Program (JFF). This program leases office space in a
building located at 501 South Street, Waunakee, Wisconsin owned by the Waunakee Community School District. The current lease expires on
June 30, 2020 and JFF intends to continue leasing this space for another year, beginning July 1, 2020 through June 30, 2021.

The negotiated monthly rental rate for this office space unit will remain the same as the current lease, at \$75.00 per month for total annual rent of \$900.00. The lease includes two renewal options for one year each with no increase in rent. JFF is responsible for utilities and the landlord will be responsible for lawn care and snow removal.
