Brief Description of Proposal -

The Land & Water Resources Department is partnering with Groundswell Conservancy, Inc. to purchase a Streambank & Public Recreational Trail Easement on land in the Town of Mazomanie and Village of Mazomanie owned by Frederick Wolf.

Current Policy or Practice -

Easements require County Board approval.

Impact of Adopting Proposal -

This easement covers approximately 10 acres and contains approximately 1,225 feet of frontage along Halfway Prairie Creek that will provide for permanent public fishing access, habitat enhancement and development of a regional multi-use recreational trail. The easement corridor will also provide public access to the existing Wolf Run Trail that connects the Village of Mazomanie to WI Heights School and a planned multi-use public recreational trail.
