NOTICE OF TRANSFERRED DEVELOPMENT RIGHTS

Pursuant to §10.304(4)(b), Dane County Code of Ordinances, Dane County hereby provides notice that a transfer of development rights has occurred in the Town of Cross Plains.

Development Rights Transferred and Extinguished: In accordance with the Transfer of Development Rights (TDR) policies of the *Town of Cross Plains* component of the *Dane County Comprehensive Plan*, the transfer of four (4) development rights from the sending property have been purchased and extinguished by a recorded conservation easement.

TDR-S Sending Property: Four (4) development rights have been transferred from the "sending" property described in attached "**Exhibit A.**" These rights include:

- two (2) development rights assigned to this property under the town's residential density cap under the *Town of Cross Plains / Dane County Comprehensive Plan*, and;
- two (2) "bonus" development rights intended to encourage conservation of lands within a "Super Sending Area," as described in the Town of Cross Plains / Dane County Comprehensive Plan.

A TDR agricultural conservation easement, as defined in §10.004(153) Dane County Code, has been recorded with the Dane County Register of Deeds under

Rights Extinguished: Rather than transfer or resell the purchased rights to a TDR-R receiving property, the purchaser, Dane County Land & Water Resources Department, has elected to extinguish the rights entirely, for conservation purposes.

Rights Remaining: After this transaction, the TDR-S Sending Property shall retain the right to create one (1) additional residential lot for a new home under the Town/County density cap, and to separate the existing farm residence and associated farm buildings from the balance of the farm, subject to Chapters 10 & 75, Dane County Code and the *Town of Cross Plains / Dane County Comprehensive Plan.*
