The Testing is a molecular *in vitro* diagnostic performed by Exact Sciences for the qualitative detection of SARS-CoV-2 RNA from human respiratory specimens. Target turnaround time for Testing results will be approximately 48 hours from Exact Sciences' receipt of a Testing order and specimen pursuant to Exhibit C; such target turnaround time is an estimate only, and actual turnaround time will vary depending on laboratory availability, raw material availability, and other factors. Notwithstanding the contents of the Specimen Collection Supplies, alternative testing materials deemed to be equivalent by the FDA and the CDC may be used by Provider's HCP to collect the specimen.
