Brief Description of Proposal -

The Wisconsin Department of Health Services is adding to its funding for the Aging and Disability Resource Center (ADRC) of Dane County. This addition is coming as a result of specific funding for ADRCs in the federal Coronavirus Relief and Economic Security (CARES) Act. The purpose of this funding is to allow ADRCs in Wisconsin to prevent, prepare for, and respond to COVID-19.

The ADRC of Dane County is the primary place for people to obtain unbiased, accurate information on all aspects of life related to aging or living with a disability. The ADRC is a one stop shop to get information for yourself, or if you are a concerned family member, friend, caregiver, or other professional. The ADRC provides information on a broad range of programs and services and helps people understand the various long-term care options available to them, helps people apply for programs and benefits, and services as the single entry point for publicly funded long-term care. All functions of the ADRC have continued remotely during the pandemic and these funds will help defray some of those costs as well as to notice the community that the ADRC remains open for business.
