In Re: Dane County Cash Bail Order Amounts By Race

Dear Supervisor Bayrd:

On Tuesday, May 7, 2019, you forwarded an email to me and several others regarding a Facebook posting which asserted that on May 1, 2019, Black people in our Dane County Jail with a cash bail order had a median bail amount of \$4,000, while everyone else had a median bail amount of \$1,250. You were not aware of the underlying data or source used to make this assertion. You asked if any one could confirm the accuracy of this information.

I responded to you indicating that while I had no way of investigating specific cash bail orders for jail inmates on May 1, 2019, I believed that I could obtain accurate data for Dane County Jail inmates on May 3, 2019 given that I happened to have collected data from the "Current Inmates" database available on the Sheriff's public website on May 3rd.

THE BOTOM LINE: For Jail Inmates with Pre-Trial Status on May 3, 2019, when considered case by case, Black and Non-Black inmates have an identical median cash bail amount of \$1,000; when total cash bail amounts for all of a defendant's cases are compared for each individual inmate, Black inmates have a median cash bail amount of \$2,500, while Non-Black inmates have a median cash bail amount of \$3,000.

The underlying data and how these conclusions were reached will be provided in the remaining parts of this letter.

Please note, this letter is informational only and is not intended to convey support or opposition to specific legislative decisions of the County Board, including issues related to future planning for the Dane County Jail.

It's important to remember that an *average* (sometimes called the *mean*) is a number calculated by adding quantities together and then dividing the total by the number of quantities.

A *median* is the middle number of an ordered, sorted list of numbers; when there is an even amount of numbers in the list, which means there is a pair of middle numbers, the median is the average of the two numbers. Finding the median is a common way to statistically measure the center of a numerical data set, and is especially important when the data set is relatively small and contains outliers which might be non-typical very large or small numbers.

In the data set of cash bail amounts being considered here, bail amounts range from as low as \$100 and as high as \$500,000, and we are counting at most 135 cases and even fewer when sub-groups are sorted out. In this set the median, and not the average, would be statistically informative.

Using the Sheriff's Current Inmates public database, for May 3, 2019 we find the following data:

- On May 3, 2019, out of 796 total jail inmates, there were 99 individual
 Dane County jail inmates with a status of Court Order Pretrial (12.4% of
 all jail inmates). This is the group to focus on; others with holds,
 prearraignment or serving sentences would not have functional cash bail
 orders.
- It turns out that 17 of those individual inmates had a pre-trial status listed, but actually did not have a cash bail order in place; some had outstanding warrants with bail suspended, some had bail revoked, and some actually had a signature bond so were probably in the jail under a different effective status.
- Of the remaining 82 individual jail inmates with a cash bail pre-trial order, 50 had only a single case, while 32 had more than one case; one inmate had 8 cases, two had 5, and others had 2, 3 or 4 open cases.
- Of the 82 individual inmates, there were a total of 135 cases with cash bail pre-trial orders.
- As expected, a large majority of those cases were Felony cases, 107 or 79.3%. The other 28 cases, 20.7%, were Misdemeanor level cases.
- For all of the 135 cases with cash bail pre-trial orders, the median amount of cash ordered was \$1,000.

- If we add together all cash bail orders for inmates with more than one case, which means we would count only 82 individual inmates and calculate each inmate's total cash bail order regardless of the number of cases, the median cash bail order rises to \$2,750.
- Of the 82 individual inmates being counted here, 49 (59.8%) are racially identified in jail and court records as Black. These Black inmates had combined 83 cases with cash bail orders (61.5% of the total 135 cases).
- Of the 82 individual inmates being counted here, 33 were racially identified as a race other than Black (40.2%), all but 5 of which were listed as White; these inmates had a combined total of 52 cases (38.5%). We can refer to this group as Non-Black inmates.
- When separated by race, cases with Black inmates *and* cases with Non-Black inmates have the same median cash bail amount of \$1,000.
- When the cash bail orders for Black inmates with more than one case are added together, the total cash bail amounts of the 49 individual Black inmates comes to a median of \$2,500.
- When the cash bail orders for Non-Black inmates with more than one case are added together, the total cash bail amounts of the 33 individual Non-Black inmates comes to a median of \$3,000.
- In summary, when considered case by case, Black and Non-Black inmates have an identical median cash bail amount of \$1,000; when total cash bail amounts are compared for each individual inmate, Black inmates have a median cash bail amount of \$2,500, while Non-Black inmates have a median cash bail amount of \$3,000.
- Table 1 below presents this data in table format.
- Table 2 attached to the end of this letter presents the raw data used for this report and summary.
- Table 3 is supplemental data also attached to the end of this letter; this table shows three random days of the Dane County Sheriff's Office Inmate Roster, giving some information regarding different status classifications for person in the custody of the Sheriff. In short, approximately 24% are inmates with pre-sentence status, 27% are sentenced inmates, 38% are inmates with a "Hold" from authorities other than the Circuit Court, and 11% are inmates "In transit" to other institutions.
