Policy Analysis Statement:

Brief Description of Proposal -

Accept grant funds from the FY 2020 Edward Byrne Memorial Justice Assistance Grant Program in the amount of \$20,460 to be used as follows: \$5,439 to the Sheriff's Office to purchase automated external defibrillators (AED's), \$9,977 for the Dane County Drug Court Treatment Program, and \$4,990 for the Dane County District Attorney Crime Response Program. Funding of \$9,977 for the Drug Court Treatment Program and \$4,990 for the District Attorney's Crime Response Program shall be reflected in the 2021 Adopted Budget. The City of Madison will administer the grant

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

Law enforcement officers are sworn to protect and serve the public including intervening in medical emergencies. Making AED's available in patrol vehicles ensures that if someone suffers from sudden cardiac arrest, the necessary lifesaving equipment and treatment will be available to save lives.
