5 6 7	The County Board of Supervisors of the County of Dane does ordain as follows:
8 9	ARTICLE 1. Unless otherwise expressly stated herein, all references to section and chapter numbers are to those of the Dane County Code of Ordinances.
10 11 12	ARTICLE 2. Section 15.41 is created to read as follows: 15.41 TRAFFIC SAFETY COMMISSION.
13	(1) As used in this section:
14	(a) Highway commissioner means the county employee having that title.
15	(b) Highway safety coordinator means the county employee having that title as
16	determined by job description or appointment.
17	(c) Member representing the field of education includes, but is not limited to, a
18	CESA administrator, school district administrator, high school principal, teacher or
19	driver education instructor.
20	(d) Member representing the field of medicine includes, but is not limited to, a
21	medical examiner, hospital or clinic executive, a physician, physician assistant,
22	nurse or a member of the emergency medical system.
23	(e) Member representing in the field of law includes, but is not limited to, a judge,
24	court commissioner, prosecutor, corporation counsel or attorney.
25	(f) A member may be appointed to the commission who meets multiple
26 27	qualification categories.(2) The Traffic Safety Commission shall consist of up to eleven members as
28	follows:
29	(a) The Dane County Highway Commissioner or other employee of the Highway
30	Department designated by the highway commissioner to act on his or her behalf,
31	who shall also act as alternative chairperson of the committee.
32	(b) The Dane County Sheriff or other employee of the Sheriff's Department
33	designated by the sheriff to act on his or her behalf, who shall also act as
34	chairperson of the committee.
35	(c) The Dane County highway safety coordinator.
36	(d) Up to five members appointed by the county executive and approved by the
37	county board for staggered three-year terms representing the fields of law
38	enforcement and other professions and including at least one or more members
39	representing each of the fields of education, medicine, law.
40	(e) Three members recommended to the county executive by the Wisconsin
41	Secretary of Transportation representing the fields of law enforcement, highways
42	and highway safety.

(3) The commission shall meet quarterly under the procedures provided in this

chapter and at such other times as called upon by the Sheriff or designee to fulfill

the duties set forth in section 83.013(1) of the Wisconsin Statutes.

- 46 (4) Under the direction of the chairperson, the Sheriff Department shall prepare
 47 and maintain all necessary documentation for the committee.
 - (5) The commission shall review traffic accident data and uniform traffic citation data and provide written recommendations for corrective actions it deems appropriate to the county board, the Wisconsin Department Transportation and other appropriate agencies regarding highway safety measures. The commission shall file a report on each meeting with the Wisconsin Department of Transportation.
