- •On August 18, County Executive Parisi signed a letter of support for a project Dane Arts is doing with the City of Madison to create more inclusion and diversity within the hip-hop music industry. The letter of support is going towards an NEA "Our Town Grant". If awarded, this grant would fund a research study in making the music industry more diverse and equitable.
- •Commissioners will be assigned specific grant applications to review.
- •247 artists received funding by the Dane Arts Need Grant (DANG!) Program.
- •The Dane Arts Professional Artist Registry (DAPAR), an online web application, is in process. This project is designed to give local artists more exposure and access to potential buyers.
