F. Presentations

1. Salmo Pond Accessible Fishing Pier & Possible Naming

Marsh stated that the Salmo Pond Fishing Pier was nearing completion. The pier was washed away during the 2018 flood. RIPP and Marsh noted that there are discussions underway on the possibility of dedicating the pier in memory of Dan Wisniewski, a former park commissioner who passed away in 2020. All proposed dedications are brought to the Park Commission for review and action.

G. Reports to Committee

1. Capital City Trail Projects and Timelines

DeSmidt provided an overview of all the projects that will be taking place on the Capital City State Trail and an area locally known as the Roundabout in the City of Fitchburg. DeSmidt explained that the Parks will be restoring the trail surface on the CCT trail this Fall and the portion of the trail from Seminole Highway to the Cannonball trail will be closed for the resurfacing.

2. Small Game Hunting

Small game hunting was on the agenda as a follow up to broader discussion about hunting opportunities on Dane County parkland. Marsh stated that the County has about 3,400 acres across 19 properties open for small game hunting. The Commission asked staff to confirm that county parkland that is adjacent to DNR wildlife areas is designated as a county wildlife area, where appropriate.

H. Announcements

GOFORTH announced that the City of Monona is purchasing the historic San Damiano Friary, a 10-acre property with approximately 1000 feet of shoreline on Lake Monona.
