Brief Description of Proposal -

This proposal approves a contract addendum between the Alliant Energy Center and Centerplate to address the financial impact of the COVID-19 pandemic and its impact on both parties. This addendum adjusts commission schedule, capital reserve contribution percentage, extends the term of the contract by two years, and modifies a couple of other contract provisions.

Current Policy or Practice -

Section 28.05(6) of the Dane County Ordinances requires leases greater than \$100,000 at the Alliant Energy Center be approved by the County Board and County Executive.
