






This point-in-time count of persons in the Dane County Jail was completed on September 22, 2020.

This one day analysis produces a **snapshot** of the individuals in the custody of the Dane County Sheriff's Office.











### What is the Pretrial Process?




#### What is the Pretrial Judicial Status?

- It is a distinction assigned to an individual in the jail record, and is based on the status of their case
- It does not overlap with any other status
  - Holds
  - Transfers
  - Writs
- This distinction can be seen on the DCSO website Inmate Listing and the Daily Inmate Population by Demographics






### In Custody Population Demographics


