Kevin Hahn appears to be of good character with good intentions and makes verbal statements around keeping operations minimal, but the CUP does not protect the township from rapid expansion or leasing/sale of the site to a more industrialized operation. If Kevin wishes to proceed, a detailed plan needs to be presented around engineering, safety, and traffic planning. The quarry cannot have a negative safety or budget impact on the community which unchecked expansion certainly would. Kevin and his team appear to be upstanding members of the community, but allowing a CUP here without extremely detailed plans, restrictions on scale, and plan for compensation is irresponsible. This is no different than restrictions placed on any business or industry operating within a community. The proposed quarry expansion abuts directly a 1845 historic home (Sereno Graves House, which we own) as well as an adjacent 170 year old cemetery that is still actively used. The blasting in the area could damage the stone foundation of this historic home. The expansion would generate noise and unrest immediately adjacent to the cemetery, which should be a community place for peace, mourning and remembrance. The existing quarry entrance is up a hill and unsafe; the proposed new entrance is down the hill too close to the cemetery. The noise and heavy traffic in the area and roads is already affecting the standard of living in our community, and would only get worse if the quarry expansion is approved. The Sereno Graves House is a key historic site in the state and its initial builder, Sereno Graves, built several other early buildings and was a community leader. The proposed quarry is at the epicenter of these historic area and would severely detract from its historic character and from a heritage that should be safeguarded and promoted by our township, county and state, and not wasted away with industrial projects. There are already several quarries in the immediate area.
