A motion was made by RITT, seconded by SHORT, that the Minutes be approved. The motion carried by a voice vote 6-0.

C. Action Items

- 1. Media Buys: Update/Discussion/Action
 - 1.1. Discussed ways to reach a broader audience with radio PSAs. RITT suggests waiting to talk to Equity office. RITT and WYATT suggest sending PSAs to Rooted and Food Council. BARTELL will ask radio station about their demographics. 30-second topics of fall planting and fall watering of trees were chosen.

A motion was made by WEISS to change wording in one of the PSAs, then the motion was retracted.

- 2. Social Media Update/Discussion/Action
 - a) Facebook boosted post on dying ash reached 737, many likes and shares. 2nd post needed.
 - b) Next Door post (free) brought 80 comments after just 6 days of posting. 34408 impressions were also noted in statistical report. Discussion: What to do about questions put in Next Door in response to our posts? Not feasible to monitor. Suggest adding a include link to WAA to find a certified arborist. WYATT recommended having a disclaimer not endorsing any company, and saying no posts from professional/commercial companies are endorsed by DCTB—consult with a certified arborist, people should check for insurance.
 - c) PSA topic suggestions for winter, pruning oaks, tree diversity highlighting trees, conifers and other trees and salt
- 3. Working Groups: Discussion/Action.

Should they be made into formal work groups? BARTELL suggested the Board may want to create other work groups to be more efficient, accomplish more, expanding to do other things that are in our mission statement such as community forestry, forestry policy and natural resource issues.

WYATT asked if any work was being done by a partner that the Board could support. Potential partners would be DNR Urban Forestry, Dane County Parks, UW-Madison, Madison Community Foundation, and Urban Tree Alliance. Need to identify county needs that we can assist with. Voucher for funds to support discount on buying a local tree for private lands?
