APPROVING AGREEMENT FOR COMMUNITY DEVELOPMENT BLOCK GRANT LOAN RENEWAL FOR WISCONSIN WOMEN'S BUSINESS INITIATIVE CORPORATION

Policy Analysis Statement:

Brief Description of Proposal -

Renews a \$100,000 loan from the County's Economic Development Revolving Loan Fund (ED-RLF) to Wisconsin Women's Business Initiative Corporation (WWBIC) to continue a micro-enterprise loan fund that provides loans of up to \$25,000 to graduates of WWBIC's entrepreneur training programs, which are funded in part with Dane County CDBG.

Current Policy or Practice -

The County's ED-RLF makes loans to businesses to create and retain jobs that benefit low and moderate-income persons living in Dane County outside the City of Madison.

Impact of Adopting Proposal -

The loan is within the ED-RLF policies, and will enable WWBIC to continue lending to micro-businesses smaller loans (less than \$25,000) than ED-RLF staff is able to support. Since this is a rollover of a previous loan, no new funds will be disbursed from the County, and interest payments will continue to be received on a semi-annual basis.
