# C. Discussion Items

### Active Threat Review

This will be tabled until January. Meier will send document out for January meeting. The intent was to have a tabletop exercise in 2020 and use that to provide any feedback on changes to make to the document.

## Mass Casualty Trailer/Kit Training Program

Meier reports that the MCI trailer, SALT triage kit, and other mass casualty supplies were brought to District One EMS to do mass casualty incident training. These resources are available as an option for other agencies to take advantage of once in-person training becomes more feasible. Meier and Eric Anderson will be piloting a Zoom Base Hospital exercise. DCEMS office did much more training last year by showing up at stations and working with on-duty crews to talk about Base Hospital. Would like to keep that going in 2021, virtually until possible to do in person. Patrick Anderson asks what trailers are available for deployment in the county and from where. Meier confirms with Stacey Hanson that one is located at the airport, one at Madison Fire Station 12, and one at Fitch-Rona EMS. A fourth is available for training and pre-planned events and is stationed at Dane County Emergency Management's new Fitchburg location. Motion by Eric Lang to recommend to MABAS Division 115 that airport mass casualty trailer be the first deployed to southern districts, Station 12 trailer to be sent to north/northeast districts, and Fitch-Rona trailer to be sent to others. Second by Wunsch. Meier to send out Powerpoint and info on upcoming trainings.
