**AMENDING CHAPTER 12 OF THE DANE COUNTY CODE OF ORDINANCES, REGARDING ZONING FEES**

**Policy Analysis Statement:**

Brief Description of Proposal -

The sign fees needed updating to correspond to the updated zoning ordinance. In the zoning ordinance, a key change to the sign regulations was focusing on physical attributes of the sign, versus the content. For instance, instead of referring to a use like "apartment complex", the ordinance refers to "ground sign". There are no anticipated budget impacts.

Current Policy or Practice -

Currently there is a mismatch between the language in the zoning ordinance (Chapter 10) and the fee ordinance (Chapter 12). This makes both ordinances difficult to administer.

Impact of Adopting Proposal -

The language in the fee ordinance will correspond to the language in the current zoning ordinance. Chapter 10 and Chapter 12 will be much easier to administer.
