AUTHORIZING A CONTRACT ADDENDUM BETWEEN DANE COUNTY AND THE YMCA OF DANE COUNTY

The Department of Administration has a current contract with the YMCA of Dane County to provide Onsite Fitness Programs for Dane County Employees which was the award of RFP #117074. The Department of Administration receives funding from Dane County's Health Insurance provider to fund the Onsite Fitness Programs. Both parties would like to extend the contract starting January 1, 2021 and ending on December 31, 2021 in the amount of \$28,510.40. This contract may be extended at the County's option for up to three (3) additional one year terms under the same terms and conditions applicable to the initial term.

NOW, THEREFORE BE IT RESOLVED, that the contract addendum with the YMCA of Dane County, 711 Cottage Grove Rd, Madison, WI, 53716 is hereby approved and that the County Executive and County Clerk are authorized to execut the Purchase of Services addendum with the YMCA of Dane County to provide onsite fitness programs.



DANE COUNTY CONTRACT ADDENDUM

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and YMCA of Dane County (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract #13232, have previously entered into a contractual relationship pursuant to which Provider shall provide onsite workout classes at Dane County work locations, and

WHEREAS County and Provider wish to amend the Master Agreement in order to extend the contract through December 31, 2021.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

- The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
- 2. The term of the contract is extended through December 31, 2021 to continue the program for Onsite Fitness Programs, at an additional cost of \$28,510.40.
- 3. Schedules A & B are replaced with the attached.

OTHER PROGRAMMING

Meditation class: \$82.4/class x 32 weeks x 1 class/week= \$2,636.80 Quarterly Lunch N Learn: \$50/hour x 4 quarters x 4 locations = \$824

2021 Program Year

1/1/2021 -12/31/2021: \$82.40/class x 38 weeks x 8 classes/week= \$25,049.60

Other programming to be provided during the year will include:

Total Yearly Cost not to exceed: \$30,000

Sign-ups for the programming will be done by Dane County. Invoices will be submitted quarterly by the YMCA.
