AUTHORIZING SIXTH AMENDMENT OF PURCHASE OF SERVICES AGREEMENT FOR MARKETING AND ADVERTISING SERVICES FOR THE DANE COUNTY REGIONAL AIRPORT

Purchase of Services Agreement No. 12910

Under Purchase of Services Agreement No. 12910 (the "Agreement"), Dane County Regional Airport ("DCRA") is provided marketing and advertising services by Affirm Agency LLC. The services provided by Affirm Agency LLC include general marketing and advertising services for DCRA, as well as marketing services furnished under DCRA's Community Air Service Support Program for the promotion of non-stop flights newly offered from DCRA to qualifying destinations. The sixth amendment to the Agreement extends the expiration date of the Agreement for one year, until December 31, 2021, and establishes a maximum cost of \$450,000 for marketing and advertising services to be provided by Affirm Agency LLC during calendar year 2021.

NOW, THEREFORE, BE IT RESOLVED that the Dane County Executive and the Dane County Clerk are authorized to execute on behalf of Dane County a Sixth Amendment of Purchase of Services Agreement for Airport Marketing Services, to extend the term of the Agreement through December 31, 2021 and to establish a maximum cost of \$450,000 for services to be provided during the extended term, as set forth above.

SIXTH AMENDMENT OF PURCHASE OF SERVICES AGREEMENT FOR AIRPORT MARKETING SERVICES

POS Agreement No. 12910
Affirm Agency LLC

THIS SIXTH AMENDMENT OF PURCHASE OF SERVICES AGREEMENT for Airport Marketing Services (the "Sixth Amendment") is entered into by and between Dane County ("County") and Affirm Agency LLC ("Affirm") and shall be effective upon County's delivery of a fully signed original of the Sixth Amendment to Affirm.

WITNESSETH:

WHEREAS COUNTY AND AFFIRM are parties to Dane County Purchase of Services Agreement No. 12910, as previously amended (the "Agreement"), pursuant to which Affirm provides advertising and marketing services for Dane County Regional Airport ("DCRA"), including marketing services for newly offered round trip flights serving DCRA that qualify for promotional services under DCRA's Community Air Service Support Program ("CASSP"); and

WHEREAS COUNTY desires to extend the term of the Agreement for an additional year, as provided for in the Agreement, and to establish the maximum cost for advertising and marketing services to be furnished by Affirm during calendar year 2021;

NOW, THEREFORE, County and Affirm agree as follows.

- 1. The Agreement shall remain in full force and effect unchanged in any manner by this Sixth Amendment except for those changes set forth below.
- 2. The term of the Agreement, as set forth in Section I thereof, is extended for an additional year, such that the Agreement expires on December 31, 2021.
- Section V of the Agreement is deleted in its entirety and replaced with the following:
 - V. <u>PAYMENT</u>. COUNTY shall make payments for services rendered under this Agreement based on the rates specified in the Schedule of Rates and Charges attached hereto as Exhibit B. COUNTY shall not be required to pay more than the sum of \$450,000 for marketing and advertising services furnished by PROVIDER during calendar year 2021.
- 4. The parties may evidence their agreement to be bound by the terms of this Sixth Amendment upon one or more counterparts of the document, which together shall constitute a single instrument. A photocopy, facsimile, or electronic copy of this Sixth Amendment shall have the same effect for all purposes as an original document.
