## **CARES Program Basics**

#### CARES grant \$10,016,000.00

- \$9,636,966.65 in direct rental assist (TRC Admin cost 2.6%)
- 15970 Individuals received assistance 7714 minor children 10,565 Households
- 87.7% Identified as people of color
- 52.9% Identified as Non-Hispanic/Latinx
- Other housing related supports provided through the CARES Program
  - Housing Counseling
    - Trained housing counselors provide landlords and tenants with information and referrals, education about rental rights and responsibilities, and access to conflict resolution. Our housing folks work diligently to empower the community to obtain and maintain quality affordable housing by providing empowerment-based tenant counseling, education and assistance. The goal is to help tenants learn their rights and take action to resolve housing problems.



## On The Ground in Dane County

Increases in rent, non-renewals, unlawful fees/fines, eviction notices, increased non-rent violations being reported (leading to police calls and eviction).



Confusion between CARES and WRAP programs.

Large increases in Latinx households being evicted and need for more dedicated supports throughout Dane Co for immigrant communities.

Lack of access to court and delays in mail causing evictions by default.

- [ISSUE] Zoom Court difficult to navigate / tenants lack minutes or internet
- [SOLUTION] TRC Outreach contact prior to and during court to provide support and access

## Things we know and have learned...

People are resilient and creative

Everyone is overwhelmed and shutting down

Separation and the unknown creates fear and knee-jerk reactions causing increased instability in health, housing and the community in general.

TRC has \$40 million in rental requests on hold.

(Upstream Prevention) Legal knowledge and (Downstream Prevention) Legal representation are minimal costs compared to the cost of displacement and homelessness.

#### Recommendations:

- Funding for community based partnerships to provide Housing Counseling / Navigation (trained, paid community members from within high risk areas throughout the County) = Upstream Prevention
- 2. Additional funding for security deposit/first month's rent available community wide
- 3. Partnerships with property management / property owners to provide support and education as well as direct rental assistance.
- 4. CARES 2.0 ⇒ Engage landlords proactively **\**stress on tenants

Rental assistance (Est \$10 million/month needed through pandemic w/amount decreasing until economic recovery)
