1. Approve 2021 DCYA High School Survey

Brian Koenig of K12 Associated summarized the survey development process, school district participation, and administration procedures. Benson summarized the survey content in context of the WI Youth Risk Behavior Survey—the DCYA is a comprehensive and unique data set used to address community health outcomes.

#### Review YC Chair Roles and Committee Opportunities

Benson reviewed roles of the Chair and Vice Chair, asking current membership to consider the opportunities in preparation for the Chair vote at the January meeting. Committee opportunities include the DCYA Steering Committee that will reconvene in April 2021 after the survey administration concludes in March and K12 Associates has created data tables for review. Williams expressed interest in joining the DCYA Steering committee.

### 2. Review Commission Roles and Opportunities

Benson reviewed the DYC Expectations and Activities. Joers inquired about whether the Commission will continue holding youth listening sessions. Benson explained the process and recommended listening sessions continue. Kata and Morales commented on the value of the listening sessions and how the process shone a light on the inequities in the community and where interventions should focus. Benson suggested alternating listening sessions with regular YC meetings in 2021. Stampfli recommended the Commission loop back to groups visited in 2019 informing them on how their input affected the community.

Supervisors Haasl and Joers reported the budget passed with few new initiatives given the Department reduction targets. No youth programs were cut or eliminated.
