#### C. Reports to Committee

Clerk Esqueda presented on the Clerk's fees. A copy of his presentation is attached to these minutes.

Dorl asked how individuals were made aware of the fees and the waiver process. Esqueda explained that the process was administrative and initiated by staff. Bayrd and Wegleitner asked follow up questions regarding the waiver, and Esqueda explained. Wegleitner asked that the court form (CV-410) be distributed to the subcommittee. Davis asked if interest accumulates on delinquent fines, and Esqueda explained how the collection process worked. Baring asked about the cost associated with the collection process, and Esqueda provided information about the new process costs. Sparkman asked who benefits from the interest on the fines and fees. Esqueda explained that the interest income ultimately is paid into the County. Davis asked whether DOR could present to the subcommittee, and Bayrd stated she would look into whether it would be possible.

Judge McNamara presented on the Court costs and fees. A copy of his presentation is attached to these minutes. Bayrd asked whether the court assessments are collected through the Clerk of Court's program, and Judge McNamara confirmed that it was. Sparkman asked whether it was true that the Judiciary could use its discretion to waive court costs and fees. Judge McNamara said a judge could exercise its discretion but it may be appealed. Sparkman asked whether Judge McNamara would agree that the exercise of this discretion could be discriminatory, and the Judge acknowledged it was. Dorl commented on the potential discriminatory nature of such discretion. Ozanne provided background on the creation of state fines and fees.

Wegleitner asked whether the number of fee petitions have fallen since the onset of the COVID-19 changes made to Court operations. Esqueda explained he did not track it but will do so. Wegleitner asked how notarizations take place, and Esqueda explained his staff can do so.
